The Engager undertakes to clearly mark each section where a term or condition is to be negotiated that is different from the PSD's stated minimum or maximum, and to clearly specify these changes in an attached Schedule or rider. The Artist will be given a minimum of 24 hours to fully consider this contract and has the right to request clarification from the Engager on any section which causes the Artist concern or confusion prior to signing. The Artist has the right to propose changes to the terms or conditions specified by the Engager if the Artist feels that those terms or conditions are unsafe, unhealthy, or under-compensated. Any renegotiations of specified terms or conditions in this contract are to be conducted in good faith by both the Engager and the Artist toward a mutual resolution, and specified in writing.
